The Great American Outdoors Act National Parks and Public Land Legacy Restoration Fund (GAOA LRF) is a commitment to protecting and sustaining our public lands.

Established on August 4, 2020, GAOA LRF allocates over \$1.6 billion annually from fiscal years (FY) 2021 through 2025 to the Department of the Interior (Interior) to address priority deferred maintenance and repair needs on public lands and Bureau of Indian Education-funded schools. With all five years of GAOA LRF funding, Interior bureaus will:

- Fund 396 projects across 50 states, the District of Columbia, and multiple territories
- Address over \$5.9 billion in deferred maintenance and repair
- Improve the condition of over 3,800 Interior assets

Deferred Maintenance and Repair in South Dakota

In South Dakota, the total deferred maintenance and repair (DM&R) backlog for the four Interior GAOA LRF bureaus is \$256,104,000**.

GAOA LRF in South Dakota

With the full five years of funding, GAOA LRF will invest nearly **\$92.6 million** towards improving over **60** assets across **9** projects in South Dakota.

As of September 2023, Maintenance Action Teams have completed work at **2** FWS locations in South Dakota.

Wounded Knee District School – Replacement

Wounded Knee District School is an Oglala Lakota Sioux Nation school serving students in grades K-8. The existing campus is in poor condition and inadequate for current student and staff needs, which impairs student learning capacity. This project will replace the existing campus with new, energy efficient academic facilities. The project will provide students with a safe and functional learning environment, which will help improve their ability to learn and grow.

Improve Resilience and Modernize Flood Damaged Buildings & Recreational Assets

Lake Andes National Wildlife Refuge is a critical wetland habitat for migratory birds and provides many recreational opportunities for visitors including fishing, wildlife observation, and environmental education and interpretation. This project replaced the flood-damaged headquarters building. The new headquarters building will allow staff to administer environmental protection and public programming. Future support building construction is planned for 2025.
