Great American Outdoors Act

National Parks and Public Land Legacy Restoration Fund

The Great American Outdoors Act National Parks and Public Land Legacy Restoration Fund (GAOA LRF) is a commitment to protecting and sustaining our public lands.

Established on August 4, 2020, GAOA LRF allocates over \$1.6 billion annually from fiscal years (FY) 2021 through 2025 to the Department of the Interior (Interior) to address priority deferred maintenance and repair needs on public lands and Bureau of Indian Education-funded schools. With all five years of GAOA LRF funding, Interior bureaus will:

- Fund 396 projects across 50 states, the District of Columbia, and multiple territories
- Address nearly \$5.9 billion in deferred maintenance and repair
- Improve the condition of over 3,800 Interior assets

Deferred Maintenance and Repair in Missouri


In Missouri, the total deferred maintenance and repair (DM&R) backlog for the four Interior GAOA LRF bureaus is \$207,692,000**.

GAOA LRF in Missouri

With the full five years of funding, GAOA LRF will invest nearly **\$55.9 million** towards improving over **65** assets across **4** projects in Missouri.

As of March 2025, Maintenance Action Teams have completed work at **3** FWS locations and **3** NPS locations in Missouri.

Replacement of Office & Retirement of Deferred Maintenance Backlog

Swan Lake National Wildlife Refuge



Swan Lake National Wildlife Refuge is designated as an Important Bird Area for Missouri and provides habitat, sanctuary, and breeding grounds for migratory birds and other wildlife. The headquarters office building at the refuge was constructed in 1981 and has been uninhabitable since 2019 due to flood damage. This project will demolish the old office building and replace it with a new office building to provide a safe and accessible space for both staff and the public. The new building will improve energy efficiency, lower operating costs, and be relocated to prevent future flooding issues. This project will also make necessary repairs to equipment storage buildings, levees, and roads.

Complete Pavement Rehabilitation on High-Priority NPS Roads in Missouri

George Washington Carver National Monument, Ozark National Scenic Riverways, Wilson's Creek National Battlefield



From scenic riverways to historical sites, the national parks in Missouri are plentiful and offer visitors the chance to immerse themselves in the state's history, natural beauty, and culture. However, roads and parking areas have deteriorated with the potential to cause safety hazards and damage to vehicles. This project is repairing roads and parking lots by applying a variety of asphalt treatments at George Washington Carver National Monument, Ozark National Scenic Riverways, and Wilson's Creek National Battlefield. This project improves and extends the life of the paved areas to increase safety and experience when driving through these parks.
