YUKON AREA SALMON FISHERY CLOSURE IN SUBDISTRICT 5-D

TEMPORARY SPECIAL ACTION

Sunday, June 28, 2026, 8:00 p.m. for Subdistrict 5-D Upper
Expiration Date: Thursday, December 31, 2026, 8:00 a.m. unless superseded by subsequent special action

EXPLANATION:

This Temporary Special Action closes the Federal public waters in Yukon fishing subdistrict 5-D to fishing for Chinook and summer chum salmon by all users. This closure prohibits all directed fishing for Chinook and summer chum salmon and closes gillnets larger than 4-inch stretched mesh and longer than 60 feet. The use of fish wheels is not allowed during these closures. Selective gear such as, dip nets, beach seines, and hook and line gear may be used for nonsalmon species. If Chinook and summer chum salmon are caught while fishing for other species, they should be released alive but may be legally retained if dead.

If you are catching Chinook or summer chum salmon in a 4-inch gillnet, please move it to avoid catching these species closed to harvest. Later in the season, the use of 4-inch gillnets will be closed between the first and third quarter point of the Chinook salmon run to reduce incidental harvest of salmon closed to harvest.

REGULATION:

36 CFR 242.27(e)(3) and 43 CFR 51.27(e)(3) Subsistence taking of fish—Yukon-Northern Area is amended to read:

§ __.27(e)(3)(ii) *In Federal public waters of the following Yukon River Drainage areas:*

Subdistrict 5-D Lower (from an ADF&G regulatory marker two miles downstream of Waldron Creek upstream to the Hadweenzic River and all other adjacent tributaries, including the communities of Stevens Village and Beaver):

Effective 8 p.m. Tuesday, June 23, Chinook and summer chum salmon fishing is closed to all users. Gillnets larger than 4-inch mesh and fish wheels are not allowed. Gillnets of 4-inch or smaller mesh may be used to target other species and are restricted to 60-foot or less in length and must be operated as a set net near shore.

Subdistrict 5-D Middle (from the Hadweenzic River upstream to 22 Mile Slough, including the Porcupine River, all other adjacent tributaries, and the communities of Venetie, Chalkyitsik, Birch Creek and Fort Yukon):

Effective 8 p.m. Friday, June 26, Chinook and summer chum salmon fishing is closed to all users. Gillnets larger than 4-inch mesh and fish wheels are not allowed. Gillnets of 4-inch or smaller mesh may be used to target other species and are restricted to 60-feet or less in length and must be operated as a set net near shore.

Subdistrict 5-D Upper (from 22 Mile Slough to the U.S./Canada border, including all adjacent tributaries and the communities of Circle and Eagle):

Effective 8 p.m. Sunday, June 28, Chinook and summer chum salmon fishing is closed to all users. Gillnets larger than 4-inch mesh and fish wheels are not allowed. Gillnets of 4-inch or smaller mesh may be used to target other species and are restricted to 60-feet or less in length and must be operated as a set net near shore.

JUSTIFICATION:

The drainage-wide Chinook salmon outlook is for a run size of about 64,000 fish, and the Canadian-origin Chinook salmon outlook is about 27,000 fish. Escapement goals are unlikely to be met for Chinook salmon and closures will be required for the duration of their migration. The summer chum salmon outlook is for a run size of about 345,000 fish and is below the drainage-wide escapement goal of 500,000–1.2 million. Closures are warranted until in-season run projections indicate goals will be met and a surplus is available for subsistence harvest. Pursuant to the Alaska National Interest Lands Conservation Act, this Temporary Special Action (**03-KS-10-26**) closes fishing for Chinook and summer chum salmon to all users in Federal public waters of the Yukon River subdistrict 5-D due to concerns about the viability of these populations. Large mesh gillnet closures are expected throughout the entire summer season to avoid incidental harvest of Chinook and summer chum salmon. Salmon fishing closures are issued based on salmon migration timing in the area. There are no conservation concerns for nonsalmon species so they may still be targeted and retained when subsistence fishing and fishing for these species is not limited to federally qualified subsistence users.

CONSULTATION AND OUTREACH:

The Yukon River salmon outlooks and management strategies were discussed at a Federal public hearing; the Eastern Interior, Western Interior, and Yukon Kuskokwim Delta Regional Advisory Council meetings; the Yukon River Drainage Fisheries Association preseason meeting; at the Yukon River Panel and at the Yukon River Inter-Tribal Fish Commission annual meeting. The Federal manager offered formal Government-to-Government Tribal Consultation meetings with Yukon River drainage Tribal Governments upon request. The Federal fishery outlook and management strategy was sent to all Yukon Tribal and City governments on April 7. Approximately 3,500 copies of the Preseason Outlook flier were mailed to Yukon River fishing households in May.

This action was taken in coordination with the Alaska Department of Fish and Game (ADF&G) and USFWS fishery managers. The fishing schedules announced here match those issued concurrently by the ADF&G in State waters (**Summer Fishery Advisory Announcement #15**). The Federal Subsistence Regional Advisory Council Chairs for the Yukon-Kuskokwim Delta, Eastern Interior, Western Interior, and Seward Peninsula Regional Advisory Councils were notified as was the Chair and Executive Director of the Yukon River Inter-Tribal Fish Commission. Review was provided by the Office of Subsistence Management.

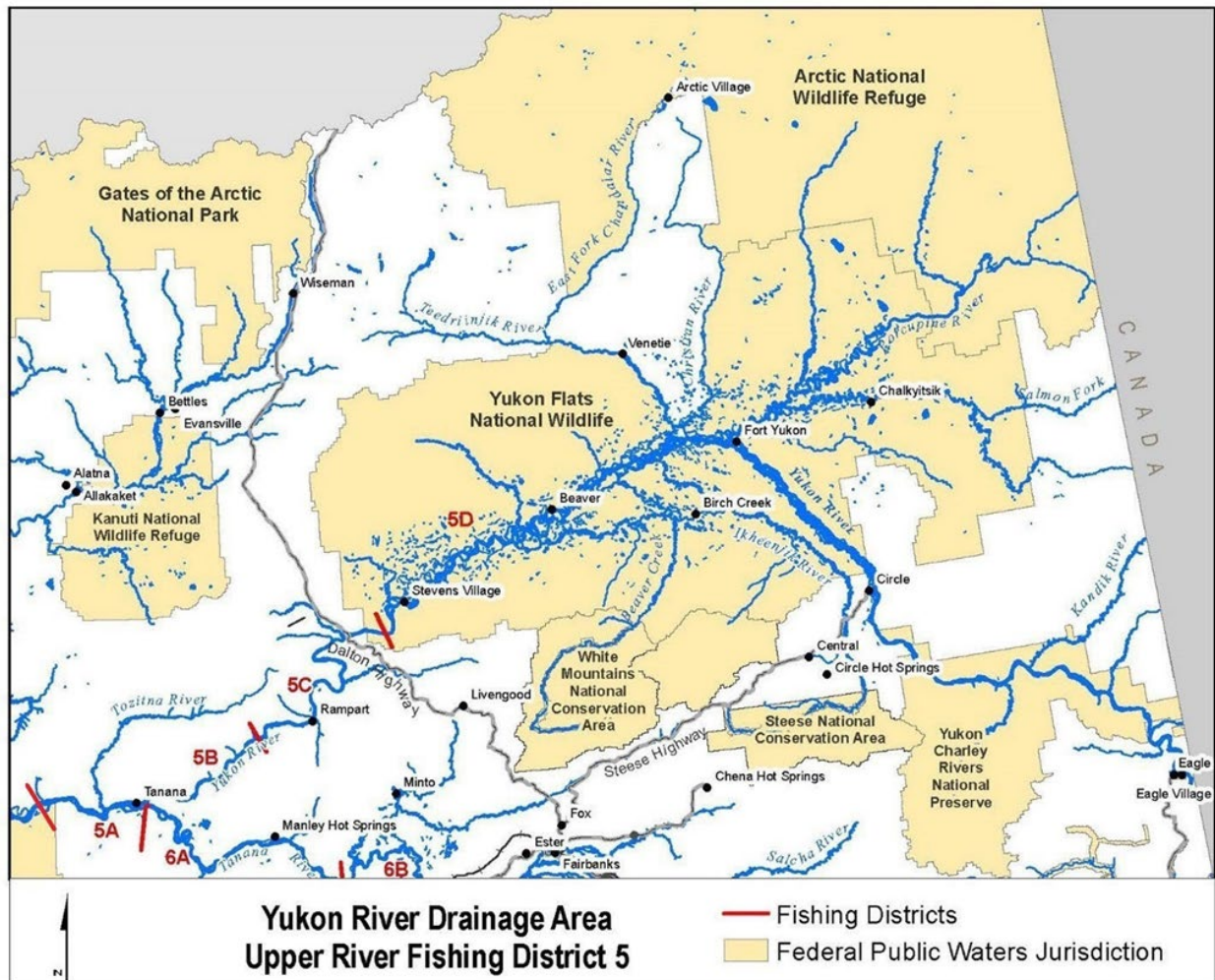

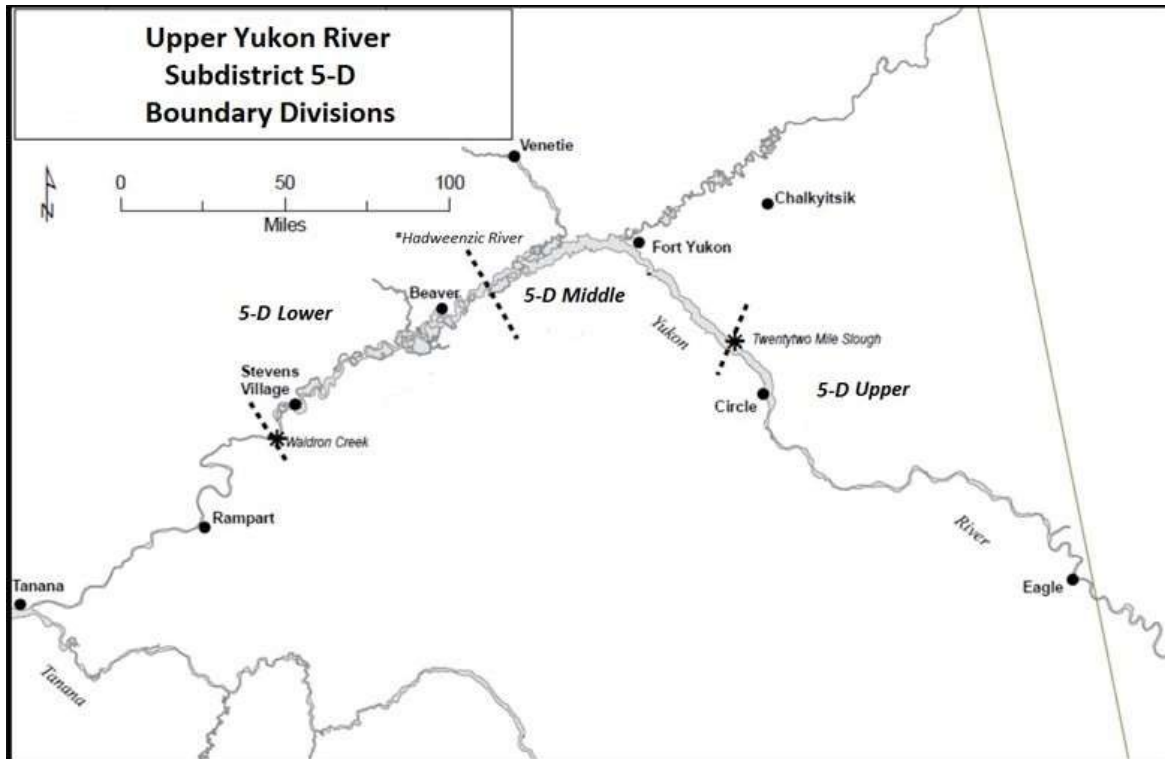

In District 5, the communities of Stevens Village, Beaver, Fort Yukon, and Chalkyitsik are in Federal Waters. Tanana, Rampart, Circle, and Eagle are in State waters.
