To follow up on a brief conversation we had at the EEI CEO meetings and Annual Convention by meeting with you to discuss Minnesota Power's outlook on "Energy Transformation" issues. In particular, we have been assessing electric system reliability issues that are emerging as part of the process for expanding the use of renewable energy resources and natural gas generation as part of ongoing energy system transformation. EnergyFORWARD is a key part of Minnesota Power's strategy to respond to ongoing energy and environmental policy challenges and opportunities going forward, outlining how our company is in process of adjusting our energy mix from about 96% coal in 2005 to about 43% renewables, natural gas and conservation/efficiency balanced energy by 2025. I would like to share some material that we discussed with FERC staff after their recent Seminars and webcasts that addressed electric system reliability subject matter (May/June).
