Would it be possible to schedule a meeting for the first week in October (October 2-6) or if we need an alternative week, the last week in September (September 25-29), we are flexible on the day in order to accommodate the team's availability. The attendees for this meeting will be representatives from ConocoPhillips and the Intermountain West Joint Venture (IWJV). We would like to help contribute toward the stakeholder process by providing our perspective and history of engagement and collaboration. We are still working to firm up the IWJV representatives but the ConocoPhillips attendees will be: Carey Farmer - Wyoming and Utah Operations Asset Manager, Donna Williams - Regulatory Supervisor, Jean Semborski - Environmental Supervisor and Kjersten Drager, Manager for Government Affairs and Strategic Advocacy. The mission of the IWJV is to conserve priority bird habitats through partnership-driven, science-based projects and programs. They were instrumental in the Sage Grouse Initiative. As the largest of the U.S. Habitat Joint Ventures, the IWJV was established in 1994 to catalyze bird habitat conservation through the collaborative power of diverse public-private partnerships. The IWJV operates across all or parts of 11 western states and encompasses some of the most diverse and intact landscapes in the West. Important habitats in this region include wetlands, sagebrush-steppe, cottonwood-lined riparian galleries, grasslands, aspen woodlands, and Ponderosa pine woodlands and savannahs. They provide continentally and regionally significant habitat for a suite of waterfowl, shorebird, waterbird, and landbird species such as Greater Sandhill Crane, Greater Sage-Grouse, Northern Pintail, Cinnamon Teal, Wilson's Phalarope, American Avocet, White-faced Ibis, Long-billed Curlew, Willow Flycatcher, and Lewis's Woodpecker. Protection of these bird species is dependent on many partners, working together in the Intermountain West, to strategically conserve large tracts of habitat needed by these species for food and cover.
