On Wed, Aug 9, 2017 at 9:53 AM, Walter Guidroz wrote: Andrea, Many thanks for meeting with us yesterday to discuss future assessment plans for the Bakken/Three Forks as well as the upcoming National Academies(NA) study of the Energy Resources Program (ERP). With respect to the Bakken/Three Forks, we are moving forward with plans to meet in Bismarck, ND on August 25th, and I believe a follow-up meeting with you has already been scheduled for Friday, September 1st (thank you Bill Lukas). With respect to our National Academies request, the kick-off meeting for this study will take place on Tuesday, September 5th at the National Academies building at 2101 Constitution Avenue NW. Briefly, this study will evaluate and make recommendations on the overall long term mission and direction for research and assessments conducted by ERP. An ad-hoc committee of 12 energy experts selected by the NA will convene the kick-off meeting to begin learning about ERP both from USGS staff as well as from stakeholders and others who use our products. As part of that exercise, we'd like to invite either you or Vincent DeVito to briefly address the committee (perhaps for about ten minutes) to provide a departmental perspective on the value that ERP brings to the Department and/or Nation as well as your views on ERP's longer term direction and focus. I've attached a statement of work FYI but briefly the charge of the committee will be the following: - Summarize the nation's geologically-based energy resource challenges including land and resource management and regulatory issues, and context from national and international energy outlooks. Describe how existing ERP data, research, and assessments currently address those challenges. - Discuss how ERP objectives and its science portfolio align with the needs of federal and non-federal consumers of ERP products. Describe how ERP may improve that alignment. - Recommend ways in which the ERP's research, data, and assessment portfolio could be developed over the next 10-15 years to benefit and serve both USGS energy priorities and those of U.S. Government. We'd appreciate any help or involvement you could provide as part of this important study. I can follow up with more details as they become available, and of course please feel free to let me know if you have any questions or would like to discuss further. Thank you. Walter Guidroz
