## **MOTION FOR REMAND**

On January 6, 2017, the Regional Director for the Bureau of Ocean Energy

Management's (BOEM) Gulf of Mexico Region (GOMR), Michael Celata, denied six

applications for permits to conduct geophysical explorations for mineral resources on the Outer

Continental Shelf (hereinafter, collectively referred to as the "Atlantic G&G Permit

Applications"). On March 2, 2017, appellants filed notices of appeal challenging the denials of the following Atlantic G&G Permit Applications: E14-001 (TGS); E14-004 (WesternGeco

LLC); E14-005 (CGC Services (US), Inc.); E14-006 (Spectrum Geo, Inc.); and E14-007

(MultiKlient Invest AS). 2

On May 1, 2017, the Secretary of the Interior, Ryan Zinke, signed Secretary's Order 3350, entitled "America-First Offshore Energy Strategy" ("Secretary's Order 3350"). Section 4a(3) of Secretary's Order 3350 directs BOEM to "expedite consideration of appealed, new, or resubmitted seismic permitting applications for the Atlantic." On May 1, 2017 and May 8, 2017, the following non-governmental organizations filed motions to intervene in the above-captioned matter: Oceana, Inc.; Business Alliance for Protecting the Atlantic Coast; Natural Resources

Defense Council, Inc.; North Carolina Coastal Federation; South Carolina Coastal Conservation League; One Hundred Miles; Defenders of Wildlife; Center for Biological Diversity; and Surfrider Foundation (collectively, the "Non-Governmental Organizations").<sup>3</sup>

Consistent with Secretary's Order 3350, on May 10, 2017, BOEM's Acting Director,
Walter Cruickshank, issued a memorandum ("May 10 Memorandum") rescinding a January 5,
2017 memorandum issued by former BOEM Director Abigail Ross Hopper, which resulted in
the original denial of the Atlantic G&G Permit Applications. In the May 10 Memorandum
BOEM's Acting Director informed the Regional Director of GOMR of his decision to request
that the IBLA remand to BOEM the appealed denials, and directed that upon remand, the
Regional Director reverse the denials of the Atlantic G&G Permit Applications so that BOEM
could thereafter resume its evaluation of those applications. In accordance with the May 10
Memorandum, BOEM hereby requests this Board remand the subject appealed matters to BOEM
for further consideration.

Given BOEM's remand request, responses to the motions for intervention filed by the Non-Governmental Organizations are premature, since the motions for intervention would become moot if the above-captioned matter is remanded to BOEM for further consideration. It is worth noting that the remand will result in BOEM's approval or denial of the Atlantic G&G Permit Applications, and will again present the opportunity for appeal and potential intervention. Therefore, granting BOEM's petition will not prejudice the parties or Non-Governmental Organizations or any interest they may have in BOEM's future determination to grant or deny the Atlantic G&G Permit Applications.

WHEREFORE, BOEM respectfully moves this Board to remand for further consideration the denials of the Atlantic G&G Permit Applications that are the subject of IBLA 2017-135, *et al.* Counsel for appellants has been contacted and has consented to this request for remand. In the event that the requested remand is not granted, BOEM respectfully requests that the Board allow BOEM ten (10) business days from issuance of its order to respond to the pending motions for intervention.
